### What's New

### iOS

- Implementation of Passenger cargo for Intrastate Cycle rules
- Changes to Exclude Driving Time Functionality

   Update to grid chart for the excluded drive time. The normally green line will now show dark grey if the drive time was excluded for the purpose of adjusting time to violation clocks.
  - Drivetime Exclusion annotation events always bound to a Driving event

#### Android

- Manage Vehicles/Trailers screen
  - Ability to add Vehicle and Trailer names with 1 character only [OOH-21719]
- Removal of Cycle Limit when Oil Well Service Permit exception is enabled when using Canadian ruleset
- DVIR PDF

- Displaying the DVIR sub-title: 'AS REQUIRED BY THE D.O.T. FEDERAL MOTOR CARRIER SAFETY REGULATIONS' when using USA cycle only and translated to French language: 'REQUIS PAR LE D.O.T FMCSA'

- Fixed an issue where the Personal Conveyance and Yard Moves buttons can't be selected under certain scenarios.

- Fixed an issue where the Agricultural Operations exception is not being completely removed after adding an event.

- Fixed an issue where the Driver Status is not updating if the vehicle is set to None.

- Fixed an issue where the Uncertified Log(s) dialog and Pending Edit Request(s) dialog are being displayed on a DVIR only driver.

- Switch/Select Equipment dialog: Fixed an issue where the Trailer search field is not working using iPhone devices.

- Fixed the issue where the Title of the DVIR PDF is not translated to French language: Rapport de la ronde de sécurité du véhicule (DVIR)

- Fixed an issue where the Engine Synchronization Compliance Malfunction is being recorded incorrectly due to Engine Sync Diagnostic's end-time did not sync to the server.

- Fixed an issue where the "Done" button on the keyboard is not working on Change Current Status dialog.

- Fixed an issue where a "24 consecutive hours off-duty required every 14 days" violation is created while in Alberta Provincial cycle.

- Certified Driver's Daily Logs PDF: Fixed an issue where the "ELD Certification" and "ELD Authentication" is displaying incorrect value when using Canadian ruleset.

- Fixed an issue where invalid violations occurred after removing an exception.

- Fixed an issue where the In-Progress DVIRs are displaying in the DVIR History screen.

- Fixed an issue where the failed DVIR points from the previous DVIR are not retained when tapping 'Pass All' button.

- Driver Logs drawer: FixeDs an issue where the End Odometer for previous days is showing the current day's end odometer value when connected to a VBUS device.

- Options screen > Shipping Docs dialog: Fixed an issue where the entered Shipping Docs cannot be removed and causes an app crash.
